Facts:

- The e-pharmacy market is burgeoning rapidly. In 2018, the global online pharmacy market was estimated at US\$49.7 billion and is expected to grow to US\$178 billion by 2026.
- The Indian e-pharmacy sector alone was estimated at more than US\$370 million in 2019, growing to US\$2.1 billion in 2023.
- There are around 20 local firms conducting e-pharmacy in Kenya. In India, where the market is larger, estimates vary at between 50 to over 100 providers.

Background:

- The recent growth of the e-pharmacy business, especially in low- and middle-income countries (LMICs), presents both risks to the public and opportunities to enhance access to health care.
- Regulatory systems - crucial in managing these risks and opportunities - are hampered by a lack of consensus on appropriate approaches and lack of national regulatory frameworks.
- Analysis of LMIC e-pharmacy markets from a health systems perspective remains very limited.

Aims:

- To address the knowledge gap by assessing the performance of e-pharmacies in India and Kenya and analysing the regulatory systems for improving medicine quality, safety and accessibility through four distinct work packages (WPs).
- To improve the quality, safety and accessibility of medicine provision.

Methods:

- WP1: Characterise e-pharmacy markets in each setting by reviewing e-pharmacy websites and conducting in-depth interviews with e-pharmacy staff.
- WP2: Assess the quality, safety and affordability of medicine provision by e-pharmacy providers.
- WP3: Critically appraise current regulations by mapping regulatory frameworks and exploring alternatives through in-depth interviews with various stakeholders.
- WP4: Study past and ongoing policy processes influencing the design and implementation of regulations through document review and stakeholder interviews.

Impact:

- This research may help guide policy makers, regulators and other stakeholders on approaches for strengthening e-pharmacy regulation.
- Clear and locally appropriate information materials on identifying trustworthy providers and using online services safely will be developed, which will be communicated through media, online channels and local non-government organisations.
